

### **SUMMARY OF THE COUNCIL MEETING OF JUNE 10th 2025**

#### Finance and administration

#### Municipal elections - postal voting

The Loi sur les élections et les référendums dans les municipalités allows a municipality to adopt a resolution in favor of postal voting for municipal elections. In view of the low number of requests in this regard, Council has resolved not to use postal voting in future elections.

## Hiring - public works

A labourer has been hired for the public works department.

#### Budget surplus transfer

In order to meet the needs of certain financial items with deficits, the Council has resolved to transfer sums from surplus items.

The items to receive these sums include public works and auditing.

#### Sale of surplus assets

The Council agreed that the Public Works Director should proceed with the sale of certain obsolete equipment, including 3 trucks, a brushcutter and a compressor.

#### **Public works**

#### Surplus - PAVL

As part of the Programme d'aide à la voirie locale (PAVL) from the Ministère des Transports du Québec, the municipality received a grant of \$106,645, which was used to seal road cracks. Council adopted a resolution requesting that the surplus funds be used to install a guardrail on Kilmar Road, where there is a significant difference in elevation.

### Awarding of contracts

A contract worth \$46,235.19 was awarded to Albert Viau for the purchase of high-density polyethylene culverts.

A contract worth \$9,000.92 was awarded to Heatlie Excavation for mowing the edges of municipal roads.

### **By-laws**

Several by-laws and draft by-laws have been adopted by Council:

- 2nd draft amendment 2025-04-902 modifying zoning by-law RU-902-01-2015 in order to change the authorized use category in zone V-07, following a public meeting held on June 10, 2025;
- By-law number 2025-05-900 amending urban plan number RU-900-2014 by adding provisions on the permutation of surface area between priority development sectors in order to make it compliant with the Land Use Planning and Development Plan of the MRC d'Argenteuil, following a public meeting held on June 10, 2025;
- 2nd draft by-law 2025-05-902 amending zoning by-law RU-902-01-2015 in order to modify the development and restriction sectors, following a public meeting held on June 10, 2025;
- Borrowing by-law 2025-05-200 amending by-law E-25-02-200 to finance the repair of a portion of Kilmar Road;
- Draft concordance by-law 2025-06-900 amending urban plan RU-900-2014 concerning the authorization of agro-industrial activities in an agricultural zone under certain conditions. A public consultation will be held on this subject on July 8, 2025 at 6 p.m;
- Draft concordance by-law 2025-06-902 amending zoning by-law RU-902-01-2015.

#### **Public safety**

Fire safety services optimization project

The Town of Brownsburg-Chatham, the Village of Grenville, the Municipality of the Township of Harrington and the Municipality of Grenville-sur-la-Rouge wish to present a project to optimize their fire safety services. To this end, the group will apply for a study grant from the Fonds Régions et Ruralité.

#### Big Red Gravel Run event

The municipality has given permission to the Big Red Gravel Run organization, which organizes an annual bike ride, to use municipal roads, notably along the Rouge River. It also authorizes the presence of municipal firefighters at the event.
