

SUMMARY OF THE COUNCIL MEETINGS OF AUGUST 12 AND 19, 2025

Public works

Numerous public works contracts have been awarded.

Culvert - Avoca Road

On August 9, 2024, heavy rains caused a culvert on Avoca Road to break away. Urgent repairs are therefore necessary to ensure the safety and durability of the infrastructure. After requesting quotes from two suppliers, Coffrage XP was selected to build a culvert head wall. The contract amount is \$31,792 plus taxes.

Repair of Kilmar Road, Belvédère sector

A call for tenders generated five bids for this work. Construction Monco Inc. was awarded the contract for \$1,024,287.03, including a contingency of \$93,117 representing 10% of the contract value before taxes, plus applicable taxes.

Supervision of work - Kilmar Project, Belvédère sector

Following a request for quotes from four suppliers, two bids were received.. The contract was awarded to HKR Consultation for \$90,177.45 plus taxes

Repair of Kilmar Road, 10th Concession sector

Following a public call for tenders, Uniroc was selected to carry out the work. The contract is valued at \$2,139,922.06, including a contingency of \$194,474.60 representing 10% of the contract value before taxes, to which applicable taxes will be added.

Supervision of work - Kilmar Project, 10th Concession sector

Following a request for quotes from six suppliers, only one compliant bid was received. The contract was awarded to Parallèle 54 for \$115,000 plus taxes.

<u>Laboratory services - Repair projects on Kilmar Road, Belvédère sector and 10th Concession sector</u>

After requesting quotes from four suppliers, Solmatech was selected for a contract in the amount of \$47,614.40 plus taxes.

Supply and delivery of abrasive sand

In anticipation of the 2025-2026 winter season, a public call for tenders was issued for the supply and delivery of 6.5 tons of abrasive sand. The company Asphalte et Pavage RF was awarded the contract, in the amount of \$141,165.08, plus taxes.

Plans and support - Grant application for the culvert on Rue des Colibris

As part of a grant application for the replacement of the culvert on Rue des Colibris, the Municipality wishes to retain the services of a firm to draw up plans and provide support. After requesting quotes from four suppliers, EFEL was selected for a contract worth \$44,900 plus tax.

Geotechnical drilling and environmental characterization of soils - Various projects

In preparation for grant applications for work planned in the 2025-2026-2027 three-year capital expenditure plan, geotechnical studies and environmental characterization work must be carried out at the sites on Rue des Colibris, Chemin Kilmar, and Parc Paul-Bougie. Four requests for quotes were sent to suppliers. The company Nvira was awarded the contract for \$43,615 plus taxes.

Surveying existing structures – various projects

Surveying work on previously paved sites on Chemin Rivière-Rouge, Chemin Kilmar in the Lilas sector, Rue des Colibris, and Rue de la Berge is required in order to prepare grant applications for projects included in the 2025-2026-2027 three-year capital expenditure plan. After requesting quotes from four suppliers, Parallèle 54 was selected for a contract in the amount of \$14,250 plus taxes.

Wildlife and flora study - various projects

In order to better prepare for the work planned in 2026 for Rue des Colibris, Chemin Kilmar in the Lilas sector, Chemin Harrington in the Dobbie sector, Chemin Rivière-Rouge in the Harrington front sector, and Chemin Avoca north of Chemin Constantineau, the Municipality wishes to conduct a wildlife and flora study. Caltha Conseils Inc. was awarded the contract for \$12,700 plus taxes.

The owners of 402 Principale Street, lot 5 925 479, have submitted an application under the Rénofaçade financial assistance program for the construction of a front porch with railings, ramparts, and stairs, with an estimated cost of \$2,789.18. The Rénofaçade program aims to improve the aesthetic and visual appearance of residences and non-commercial buildings in the Calumet and Pointe-au-Chêne sectors.

The council resolved to grant the requested financial assistance, i.e., 50% of the materials and labor costs, following the recommendation of the urban planning advisory committee. The financial assistance granted amounts to \$1,394.59.

Revised Risk Coverage Plan 2025-2035 - Argenteuil Regional County Municipality

Under section 8 of the Fire Safety Act, regional county municipalities must, in conjunction with the local municipalities that comprise them, establish a risk coverage plan for their entire territory. To this end, the council adopted the draft revision of the 2025-2035 risk coverage plan for the Argenteuil RCM for the portion of Grenville-sur-la-Rouge.

Professional urban planning assistance service contract with Apur

The council resolved to increase the amount of the contract awarded to Apur for professional urban planning assistance services by \$40,000, bringing the total contract amount to \$110,000 plus taxes.
