BUDGET 2026

The Municipality of Grenville-sur-la-Rouge has presented a balanced budget of \$9,065,117 for 2026, representing a 4.2% increase over the 2025 budget of \$8,728,211.

The MRC has sent us the new three-year assessment roll for the years 2026-2027-2028. Property assessments have increased significantly, and in order to limit the increase in the tax bill, the municipal council has reduced the base rate. As a result, we have managed to limit the tax increase to an average of 4.1% for average-value residential properties. Among the important choices and efforts that the municipal council had to make to limit spending while maintaining the quality of services to citizens were prioritizing issues, controlling costs through optimization and work efficiency, and reviewing certain expenses.

PAYMENT OF THE TAXE ACCOUNT

Tax account due dates are set at 4 installments for accounts over 300\$.
Payments for 2026 are due on the following dates:

- April 15
- June 15
- August 15
- October 15

- **Online** payment via your bank's website. The reference number is your role number, written on your tax bill.
- **Sending post-dated checks** to the finance department of Grenville-sur-la-Rouge.
- **In person**, at City Hall: by check, cash, Interac.
- **24 hour drop box** at the main entrance of the Town Hall.
